### Home & Community Care

The Mustimuhw Community Electronic Medical Record (cEMR) software is designed to support Home and Community Care (HCC) delivery in community-based service organizations. As a client-centric system the cEMR both supports safe and effective documentation for HCC staff as well as support greater coordination and collaborative care across other service delivery areas and programs within the Health Centre or clinic.



The Mustimuhw cEMR is used by Home and Community Care teams across the country. It is an easy-to-use system and is customized to support the unique needs and HCC workflow of each organization. This includes customized and standard charting and assessment tools, referral management, intake and HCC program admission, and follow-up and task management. The cEMR has a HCC scheduler to manage recurring services by assigned staff and client. Many HCC programs take advantage of the cEMR feature called, "Disconnected-Use", which enables charting in locations with no network connectivity (e.g. In community, at clients' homes). The cEMR can generate a number of standard HCC reports including eSDRT, PIP, and CBRT, as well as reports that position managers to evaluate and plan for continual service improvements. New Mustimuhw virtual care options are available for remote e-visits and secure client messaging, which are being seen as beneficial tools for HCC.

Indigenous Health and Human Service organizations continue to recognize the cEMR as an important tool for organizations to effectively manage their services and support their clients due to the system's diverse capabilities that improve coordination across providers and teams, supports reporting and business intelligence, and increases program efficiency.
